

We are Causeway and our purpose is to free marginalised and vulnerable people, including survivors of modern slavery and exploitation, to find their voice, and for society to value their place. # **Definitions:**

Marginalised and vulnerable people: Survivors of modern slavery and exploitation in the UK – women, men and children who need help living, not just existing. People who are or have been in the criminal justice system in the UK and who are willing to engage in the journey towards a positive contribution to society and thriving futures.

Free to live: Marginalised and vulnerable people face physical and psychological barriers that create circumstances of actual or presumed vulnerability and marginalisation – an environment which puts these people at risk to fall back into the cycle of crime and exploitation. They also often lack confidence, skills and the opportunities to voice, face, and ultimately overcome these barriers. Our services go above and beyond basic 'existence' support; they also free people to live as successful, positive and valued contributing members of society.

We will be a lasting and dependable organisation for the good of all our stakeholders.




### Sharing and working with others

- We will tackle the skill gap experienced by marginalised and vulnerable people, sharing knowledge, good practice and expertise, and working in partnership with others.
- We will work with all relevant government officials and authorities, such as the UK anti-slavery commissioner, to play a role in the prevention, support and protection of marginalised and vulnerable people.
- We will liaise effectively and influence positive outcomes in the work of local and regional public sector agencies who we may share responsibilities with for marginalised and vulnerable people, e.g. the police, the NHS and GP surgeries, the probation service, etc.



# Influence

- We will seek to raise the awareness and opportunity for prevention, support and protection services, and the risks associated with falling back into the cycle of crime and exploitation. We will do so by commissioning in-depth research that highlights the voices and stories of those we support; it will seek to inform society with the view to change the way marginalised and vulnerable people are viewed and valued. We will also demand and deliver greater transparency on data concerning marginalised and vulnerable people.
- We will invest in campaigns and advocate tirelessly to put the urgent need for prevention, support and progress at the fore of all strategic thinking on modern slavery and exploitation. And we will seek to influence society to better understand the positive contribution of people who have been supported out of the Criminal Justice system.
